# SPECIAL MEETING JANUARY 7, 2010

The January Union Meeting will be a Special called meeting to discuss and vote on a dues increase for the Firestop Classification. The motion will be in increase Firestop hourly dues contribution from \$.10 per hour to \$.50 per hour. That would be an increase of \$.40 per hour. Work in our territory is steady. Work in our Conference is steady too. Please call the hall and check with us on a regular basis for availability.


### PROFESSIONAL CRAFTSMAN CODE OF CONDUCT
